It has been a busy month with programming and professional development that involves traveling to Madison, Kenosha-Racine and Appleton to participate in a workshop on workforce development including employment program for individuals with conviction records. Catherine and I attended the workshop and learned about Foxccon project and its potential economic impact. This has implication for Eau Claire since Foxconn is in the process of starting an innovation center here.

In terms of programming, I continue to work with the Community Food System team and conducted a series of planning meetings, including conceptualizing and working on a Charter Statement as required by Clear Vision. We are also reviewing potential grants to support the development of community food systems in Eau Claire County. in support of local food systems, I collaborated with colleagues in Madison and submitted an application for USDA Socially Disadvantaged Farmers and Veteran grant to conduct a needs assessment and support Hmong farmers in Eau Claire and other Counties. The plan is to employ and include a Hmong second generation in this research project.

I have officially joined the Broadband Committee and we had our first meeting where we selected our chair and reviewed the direction of the project. This is an exciting project and I look forward to contributing toward its success.

September is busy with FY20 planning. Sandy, Pamela, and Joy are connecting with our partners to sign agreements and schedule events.

Sandy is planning the Hunger Prevention Coalition meeting this month to be held on September 17, 1:00 p.m. at The Community Table.

Sandy is on an EC Resource Directory Workgroup with community partners. This group is reviewing the multiple community resources, both hardcopy and electronic, that exist and discuss the benefits or possibility of having more user-friendly online resources. https://eauclaire.extension.wisc.edu/family-living/resource-directories/

The Eau Claire Downtown Farmers' Market is included in a statewide Farmers Market digital media campaign funded by FoodWlse. It runs from July 31 to Sept 15. The mission is to inform eligible audiences 18-65+ that FoodShare benefits can be used at the local farmers market. The ads are running daily on Facebook and YouTube. The goal is to increase usage of Quest cards in specific communities. Performance metrics on total impressions, click-through rates, view time,and unique reach will be gathered.

All FoodWIse staff attended a regional FoodWIse training in Merrill. This included discussion on FY20 program delivery models, evaluations, classroom management, end of year reporting, and new curriculum Cooking with Families workshop.

Joy is currently teaching a series of nutrition lessons with adults who are Foodshare/W2 recipients and are enrolled in the Real Careers program at the Workforce Resource Center. She is also working with LSS: Affinity House delivering nutrition lessons to women who are in an addiction treatment program. Both adult series are taught using "Healthy Cents" curriculum (University of Maryland Extension) which combines nutrition education and food resource management. These lessons encourage participants to make healthy food choices on a limited budget.
